Thank you for inquiring about an apprenticeship with the United Association of Plumbers and Steamfitters Local 434. Apprenticeship is a combination of on-the-job training and related classroom instruction.

- Plumbers are required to take 572 hours of day school training, 260 hours of night school training, and have a total of 8,000 work hours.
- Construction Steamfitters are required to take 624 hours of day school, 300 hours of night school, and have 8,124 work hours.
- HVAC/Service Steamfitters are also required to take 624 hours of day school, 260 hours of night school, and have 8,124 work hours.
- Each apprenticeship is five years.

Enclosed in this packet is some information to help you understand what you need to do in order to become an apprentice. Also included is a list of our union contractors. You'll need to contact these contractors and apply with them. It is your responsibility to find a contractor that will start your apprenticeship. Please fill out the applications and send back to us with a copy of your Accuplacer or ACT scores (taken within the last 5 years), High School Transcript and resume. If any contractors call us looking for possible applicants we will give them your resume.

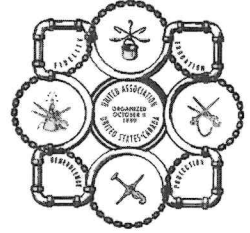

Why are you being asked to complete this form?

It is unlawful for a sponsor of a registered apprenticeship program to discriminate against an apprentice or applicant on the basis of disability. However, because of your status as an apprentice or apprentice applicant, you are being given the opportunity to disclose if you have a disability, or ever had a disability. This form is used to evaluate the inclusion of individuals with disabilities in registered apprenticeship programs. Because disability status may change or a person may wish to update their previous status, the opportunity to disclose a disability is given during the application process, at the time of registration as an apprentice, and on an annual basis during the apprenticeship. There is no penalty for disclosing a disability now that you previously did not disclose.

How do I know if I have a disability?

You may be considered to have a disability if you have a physical or mental impairment or medical condition that makes achievement unusually difficult, limits your ability to work, substantially limits a major life activity, or if you have a history or record of such an impairment or medical condition.
